GE Appliances Standard Operating Requirements 200-06 ERP SFLS (Sell from Local Stock) SOR Issue Date: 03/25/2021

1. Introduction: This document explains the use of the SFLS (Sell from Local Stock) screen in GEA Delivers for ERP orders. Local stock means product that is stored in your warehouse, locally. Typically, this stock consists of fast-moving items that have recently been cancelled off of other orders. Only GE units are eligible for local stock.

2. Context:

- Legacy equivalent:
 - Legacy SFLS was included on a MASTER and any shortages, damaged items, and serial mixes were recorded on the INBOUND screen. ERP will be handled separately, and exceptions will be reported directly on the SFLS screen (not INBOUND). See
 - Legacy SFLS required the delivery agent to report serial numbers being used to fulfill an order, while ERP will auto-assign serials based on a three-day window from the Requested Delivery Date (RDD), using First In First Out (FIFO) logic.
 - For step by step process of legacy LCLI, see document 200-7 Legacy Local Stock
- When:
 - Check your SFLS screen daily! Local stock units are noted on the POD, in the app, and on the Order Details screen in Track & Trace.
 - You must report exceptions on the SFLS screen as soon as possible so a replacement unit can be initiated.
- Why:
 - Sell From Local Stock (SFLS) is a program that identifies and uses available inventory in the Finished Goods sub-inventory at the local delivery agent's facility, reducing handling and risk of damage.
- Who to contact if there is an issue:
 - If there is an issue with SFLS, contact the GEA Delivers team at geadelivers@geappliances.com.



3. Process:

Step 1: Login to GEAD and click SFLS under the Inventory column to view upcoming orders and report exceptions.



Step 2: The **Inventory Org** and **10 Days After** fields will default; no changes are needed unless you have access to multiple locations or want to view historical data. If needed, click the dropdowns to change. The report will include orders up to 10 days *after* the day you select.
